PCYC Membership Form

Classes of Membership and their annual subscriptions:

Senior Member	\$130.00	Discounted by \$10.00 if paid before 31/10/17
Junior Member	\$ 40.00	Discounted by \$ 5.00 if paid before 31/10/17
Associate Member	\$ 70.00	Discounted by \$ 5.00 if paid before 31/10/17
Associate Family Member	\$ 70.00	Discounted by \$ 5.00 if paid before 31/10/17
Senior Active Family Member.	\$145.00	Discounted by \$10.00 if paid before 31/10/17
Youth Group.	\$130.00	

Senior Member – a member 18 years or over on Opening Day of the current season. Such a member shall be accorded all the rights, privileges and facilities of the Club as laid down in the Constitution.

Junior Member – a member aged less than 18 years on Opening Day of the current season. Such a member shall be accorded all the rights, privileges and facilities of the Club as laid down in the Constitution.

Associate Member – a membership for an adult who supports the club by an annual subscription and may give voluntary service to the Club in the like of race control, maintenance, administration or attendance. Such a member may hold full membership at another yacht club and occasionally chooses to be part of a crew upon a PCYC yacht in a PCYC event, but not as skipper (Nees Cup excluded); and such member shall not hold such privilege should their full membership lapse at their primary yacht club. Such a member shall be accorded all the rights, privileges and facilities of the Club as laid down in the Constitution, subject to the above paragraph. Such members shall not hold any trophies limited to competition within Club membership. Such membership may at any time be revoked by decision of the Committee that its continuance is inappropriate, and such member so affected shall be re-designated as a Senior Member. A change of membership class from Senior Member to Associate Member must be applied for to the Committee for approval.

Family Memberships:

Associate Family Member- may be available to any Associate Member of the Club who has applied for it in writing to the Committee. Ass' Family membership is limited to the member's Spouse or Partner. Ass' family membership shall confer on each of the two members all the rights, privileges and facilities of the Club which are enjoyed by the original Member, except that only one of the members shall be entitled to vote in the affairs of the Club.

Senior Active Family Member- shall be available to any senior member and their immediate family upon the criteria that any children covered by such membership shall fall within the age criteria below. Senior Family Membership shall confer on each member all the rights, privileges and facilities of the Club which are enjoyed by the original Member. Such Membership shall be entitled up to two votes in the affairs of the Club when exercised by at least two members being present. Family Members whose age could otherwise qualify them for Junior Membership may be awarded race points or trophies individually. Such Family (Junior) Members can apply to retain their Family Membership status if engaged in further tertiary Educational Studies up to the age of 22 years or upon completion, whichever comes first.

Youth Group Member – which status may be available, at the discretion of the Committee, to any Youth Group which applies in writing for membership of the Club. Youth Group Membership shall carry one vote in the affairs of the Club. Such a vote shall be exercised only by a representative duly appointed in writing by the group for that purpose. Any members of accepted groups whose age could qualify them for Junior Membership of the Club shall receive all the racing rights of Junior Membership while sailing as Groups in Group boats. Any race points or trophies gained by such members of the Group shall be awarded to the whole Group, not to individuals (except where the particular trophy or race rules states otherwise).

Some further points:

Changes of address; Members are expected to notify the Secretary of any changes to contact details, as soon as practicable.

Subscriptions for each season are set at the Annual General Meeting (in July each year) and become payable immediately after the AGM. The due date for payment is 31st October each year.

If a subscription becomes overdue, the member forfeits certain privileges, eg. They cannot participate in meetings, and may be disallowed points or trophies for any races sailed while their subscription is overdue.

If a member decides to resign, he or she is expected to do so in writing, and while their subscription is still current.

Information provided in this membership form will be shared with Yachting New Zealand for the purposes of meeting this club's affiliation requirements to the national body as per the Yachting New Zealand Constitution. This will allow Yachting New Zealand to send you your membership card and communicate with you (by post and electronically) in relation to your membership (e.g. by sending you emails about membership benefits and newsletters). Yachting New Zealand will not share your information with any other organisations. You are able to access and correct personal information that Yachting New Zealand holds by contacting Yachting New Zealand at PO Box 33 1487, Takapuna, Auckland 0740 or via email mail@yachtingnz.org.nz.
